Dear Village Residents,

I am pleased to share the news of the new Brookville Police Department which will take over the policing duties for our Village of Mill Neck in addition to the Villages of Brookville, Matinecock and Cove Neck on June 1, 2022.

We have been part of the Old Brookville Police Department for 30 years and they have served us well but unfortunately the Village of Old Brookville has decided not to renew the Six Village Joint Protection Agreement for Police Protection which I shared with you last year.

We have been busy with the three other Villages dotting the i's and crossing the t's to ensure a seamless transfer to the new department. Nine of the current OBPD officers will be transferring to the new department, so you will still see many familiar faces in our new department. The Brookville Police Department will be led by Chief Kenneth Lack who retired last year after 32 years of service with the Sheriff's office and Nassau County Police Department.

An important change in **EMERGENCY SITUATIONS IS TO DIAL 911** and not the Old Brookville PD phone number as the dispatchers have all left the current OBPD and we are taking advantage of the Nassau County 911 system which we already pay for in our Nassau County Police Headquarters tax. The three Village Mayors and I along with Chief Lack had a terrific tour of their facility and we all were impressed by the operation.

The new Police Headquarters is located at the Village of Brookville Nature Park at 195 Brookville Road. We will be sending out more information in the weeks ahead on this change and posting information on the Village of Mill Neck website: [www.millneckvillage.com](http://www.millneckvillage.com)

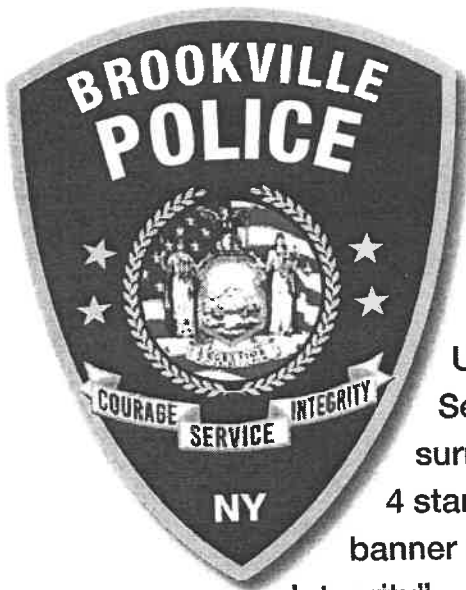

## IN ALL EMERGENCIES DIAL 911

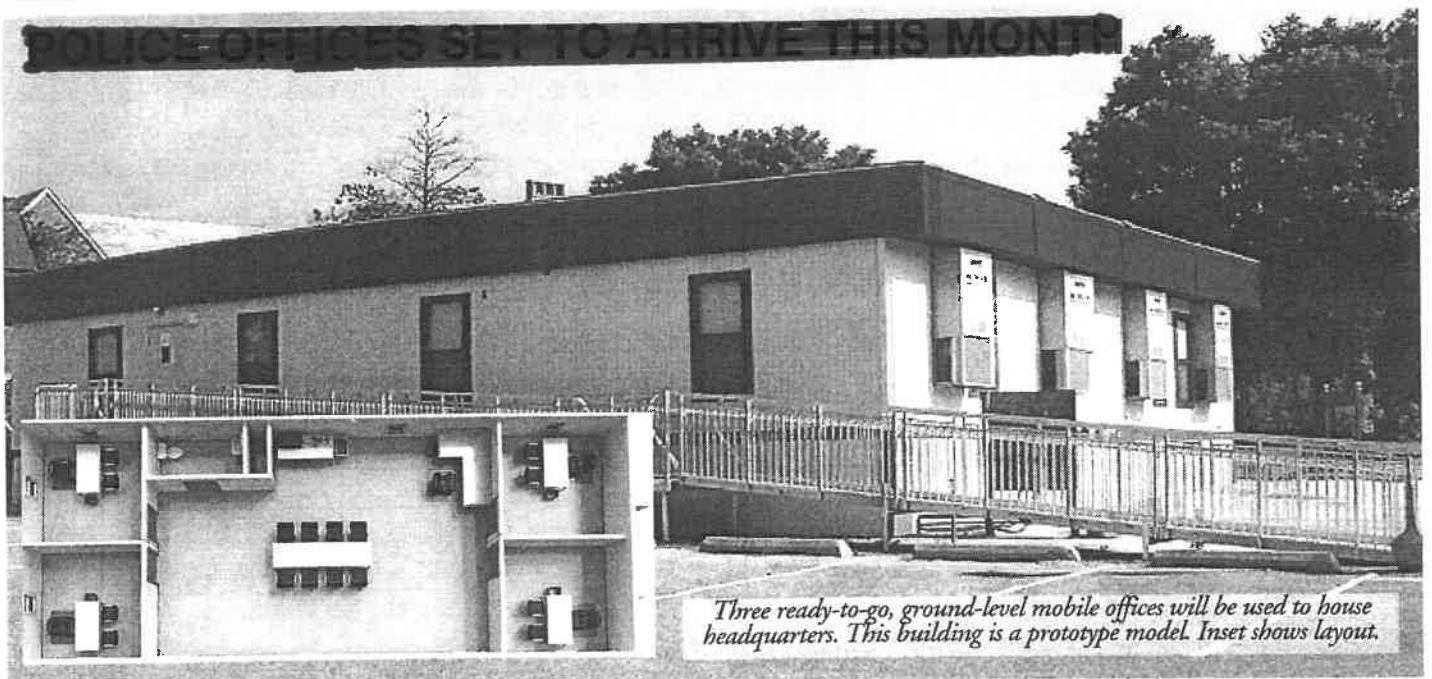

Residents will receive a Code Red call and written notification by USPS mail of the new phone number about 30 days prior. Until then, contact the OBPD as usual at 516-626-1300.



## We Are Very Proud Of Our Newly Designed Police Patch

The image at left shows our new Patch. Not only will it be worn on the Brookville Police uniforms, but you will find this symbolic image used throughout the Department.

With a background of National Police Blue bordered by Uniform Button Gold, the central icon depicts the NYS Seal superimposed over the American flag. The icon is surrounded by a wreath of laurel leaves (symbol of peace) and 4 stars (symbolizing the 4 villages the Department serves). The banner element proudly carries the 3 words of "Courage, Service, Integrity" – encapsulating the Department's core values.



# Meet Kenneth W. Lack

## Our New Chief of the Brookville Police Department

*With over 30 years' experience in law enforcement; Chief Kenneth W. Lack has had a distinguished career with the Nassau County Police Department. He will be a real asset to the Brookville Police.*

The Village of Brookville, and the Board of Police Commissioners of the 4-Village Brookville Police Department (Brookville, Cove Neck, Matinecock and Mill Neck) are pleased to announce that Kenneth W. Lack, recently retired as Chief of Patrol of the Patrol Division, Nassau County Police Department, has joined the Brookville Police Department (BPD).

With such a distinguished career, we are fortunate that Chief Lack has accepted the position of Chief with our Department. His broad and detailed experience from the NCPD, his innovative ideas, and his detailed knowledge of the structure and workings of a large law enforcement agency have already been a tremendous asset to us. **CHIEF LACK ROSE THROUGH THE RANKS FROM THE ACADEMY.** A committed and innovative leader who commands by example and exemplifies the core values of policing — integrity and professionalism, Chief Lack began his career 30 years ago, in 1990, with the Nassau County Sheriff's Department.

In October of that same year, he was called to join the Nassau County Police Department. In 2003, he was promoted to Sergeant and assigned to the Fourth Precinct as a Patrol Supervisor. In 2006, Lack was promoted to Lieutenant and assigned as a Coordinator for the Task Force Against Gangs Unit. In 2007, Lieutenant Lack was assigned to the Community Affairs Unit, promoted to Detective Lieutenant, and subsequently to Commanding Officer.

In 2009, he was promoted again to Captain. In that same year, Captain Lack was promoted to Deputy Inspector and at the request of the Police Commissioner, reassigned to the *Office of Commissioner of Police*. In this function, DI Lack had supervisory responsibilities over five of the Commissioner's direct commands. In 2012, DI Lack was transferred to the Public Information Office as Commanding Officer. Shortly after this transfer, he was promoted to the rank of Inspector. In 2015, Inspector Lack was assigned to the Office of Chief of Patrol where he served as Chief of Patrol. The Patrol Division consists of 1,700 sworn officers and over 500 professional civilian staff. This division encompasses two thirds of the Nassau County Police Department.

Chief Lack has also served as the Departmental Liaison to the NCPD Foundation. In this position, he advocated on behalf of the Department to build a new 21st century Police Academy to be called the Center for Law Enforcement and Intelligence. This incredible project was completed in June 2021.

Chief Lack has proven himself as a resourceful and creative policing executive with a consistent record of success on a wide variety of operational law enforcement and administrative assignments, including extensive experience in local community engagement. "Kenneth W. Lack, Chief of our newly formed 4-Village Brookville Police Department, is a committed and innovative leader," said Mayor Daniel Serota, "a person who will add real value to policing here in our Villages."

Chief Lack began his career in 1990, with the Nassau County Sheriff's Department.

That same year, he joined the Nassau County Police Department, rising rapidly through its ranks from Sergeant, to Lieutenant, to Detective Lieutenant to Captain.

Subsequently, Captain Lack was promoted to Deputy Inspector and at the request of the Police Commissioner, reassigned to the *Office of Commissioner of Police*, and then to the *Public Information Office* where he was promoted to the rank of Inspector.

In 2015, Inspector Lack was assigned to the *Office of Chief of Patrol* as Chief of Patrol. This division encompasses two thirds of the NCPD.

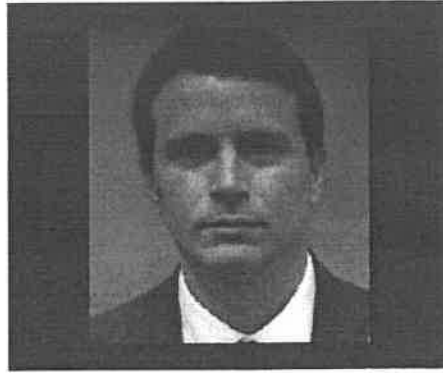


# MEET MORE OF OUR NEW OFFICERS
